- B: The weather conditions anticipated during the trip will range from: -+25 to -10
- C: The terrain in the hunting area will be but not limited to: Open fields, and water bodies
- D: Transportation in the hunting area will be: Pickup truck, quad, and foot

#### 2. Equipment/Facilities/Service provided by the Outfitter:

The Outfitter will provide the following:

- A: Accommodations will be at the lodge
- B: All meals during the time of the hunt. (Not including Alcohol)
- C: Tower stands/ Ground blinds/ willow blind.
- D: Waterfowl caller for hunts.
- E: Complete setup for water hunt example: decoys etc.
- F: Two boxes of ammunition (24 shells per box) per day.

#### 3. Equipment, clothing and services you must provide:

- A: Clothing for 20C to -10C
- B: NOT INCLUDED: Meat processing and shipping cost, taxidermist.
- C: Alcohol if wanted
- D: Firearm for waterfowl

#### 4. Cost of the hunt and payment schedule:

Total cost of the hunt is \_\_\_\_\_\_ + 5% tax 50% deposit is due upon a hunt, remaining cost due upon arrival

#### 5. Cancellation Notice and Refund Policy:

Deposits are non-refundable but may be transferred to another hunt in the same hunting season. In the event that the MC Outfitters must cancel a hunt the parties who have booked the hunt have the option to:

A: Receive a full refund

B: Transfer to another hunt in the same season when MC Outfitters can accommodate the hunt or to the following season at no additional cost.

C: MC Outfitters or guides have the right to refuse a hunt if they deem the hunter is unfit to hunt.

### 6. Client Acceptance of liability and risk:

A: The area in which you will hunt has been selected for its interest, challenge and game resources, in order to meet your expectations. You are fully capable of participating in this trip and are willing to assume the risk of injury as your responsibility.

D: You will not hold or take legal action MC Outfitter or guide working for MC Outfitters responsible for any injury or fatality that may occur or expenses arising therefor.
